Concrete Bowling Ball:

Additional Judges Needed: 3

Conference Time: Concrete bowling will be Saturday, April 13th from 8am to noon at the Hyrum Reservoir.

Rules

Responsibilities:

• Judging the bowling ball based on meeting design requirements as noted in the rules, durability, aesthetics, and how well the balls bowl a 5 frame game.

Construction Institute

Additional Judges Needed: 1

Conference Time: The Construction Institute competition will be held on Friday, April 12th from noon until 3pm at the USU Spectrum.

Rules

Responsibilities:

- Providing scope of work for one real-world engineering project, as well as any necessary documents
- Task students with a short response prompt, numerical/calculation-based prompt, diagrammatic or pictorial response
- Judge Presentations

Environmental Design: 1 Judge

Additional Judges Needed: 1

Conference Time: Thursday, April 11th. Start time is at 9 am in the USU Spectrum. It is scheduled to go until noon.

Daniel Mead Paper Competition:
