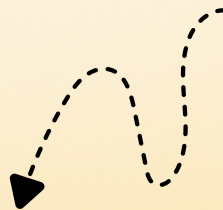

BUSINESS MEETING



The Business Meeting is provisionally scheduled to occur on **Monday, March 30th, 2026, at 1:30 PM**. Please monitor for the proposed business meeting agenda, which will be circulated via email to student chapters for review and revision prior to the symposium.

The Business Meeting constitutes the annual assembly of the Student Conference Board of Delegates. The Board of Delegates comprises **two student representatives**, ideally a senior or junior holding a leadership position within ASCE, a sophomore currently in or aspiring to an ASCE leadership role, and the **faculty advisor from each student chapter**.

The preliminary agenda will encompass unresolved discussion items from the 2025 Business Meeting, the upcoming host rotation, new business matters, the review and finalization of the Conference Policy and Procedures document, and additional topics pertinent to this ASCE Pacific Southwest Student Region.

Each student chapter participating in the Student Conference is entitled to one vote. **At least one member of your ASCE student chapter is required to participate in the Business Meeting as a condition for eligibility to advance to the finals in Concrete Canoe, Steel Bridge, Sustainable Solutions, and Surveying.**

STUDENT SYMPOSIUM PAPER COMPETITION INFORMATION

The ASCE Student Symposium Paper Competition emphasizes the importance of being able to write and present a paper as essential communication skills for all engineers and often necessary for advancement in your career. The competition consists of a paper submission and a presentation at the student symposium.

Time Limit: 5 minutes to present and 5 minutes for judges' Q&A

***All papers must have a statement at the bottom attesting that, except where otherwise cited, the submission is the work of the student author and not AI or NLP. Submissions without this statement will not be considered for recognition.

For student chapters participating in their regional student symposium, papers must be submitted to the student symposium host by March 1, 2026, using the host's preferred submission process as outlined above. A separate submission to ASCE is not required for the Student Paper Prize for Students Competition, as the student symposium submission will serve as the official entry for the Student Symposium Paper Competition. **The winning paper from each student symposium will advance to the Society competition for final review, with the official national winner announced in May 2026.**

One winner from the ASCE Pacific Southwest Student Symposium will be named the Symposium Paper Competition Champion.

SOCIETY-WIDE FINALS ELIGIBILITY REQUIREMENT

Both the paper submission and the presentation are mandatory for any ASCE Student Chapter participating in the 2026 ASCE Pacific Southwest Student Symposium that wishes to be eligible to advance to ASCE Society-wide competition finals and SSBC National Finals. Competitions requiring participation include:

- ASCE Concrete Canoe Competition
- ASCE Sustainable Solutions Competition
- ASCE UESI Surveying Competition
- AISC/ASCE Student Steel Bridge Competition



Please note that any papers/presentations created for any other competition do not count as an entry into the Student Symposium Paper Competition.





ASCE COMPETITION ELIGIBILITY REQUIREMENT REMINDERS

ELIGIBILITY FOR STUDENT SYMPOSIUM COMPETITION

The following qualifications are required of all ASCE Student Chapters to compete at the Student Symposia Competitions:

An ASCE Student Chapter must:

- Be in good standing with ASCE:
 - Have paid their annual dues, as received by ASCE, **no later than the start of their Student Symposium**
 - Have submitted their student chapter's full Annual Report or EZ Annual Reporting Form, **no later than February 1, 11:59 PM ET**

ELIGIBILITY FOR ASCE SOCIETY-WIDE COMPETITION FINALS

The following qualifications are required of all ASCE Student Chapters in order to advance to the ASCE Society-wide Competition Finals:

An ASCE Student Chapter must:

- Be in good standing with ASCE
 - Have paid their annual dues, as received by ASCE, **no later than February 1, 11:59 PM ET**
 - Have submitted their student chapter's **full Annual Report**, **no later than February 1, 11:59 PM ET** and have received a minimum score of 25 points out of a possible 100. **Student Chapters that submit an EZ annual reporting form do not qualify** to advance on to competition finals
- Attend and participate in their assigned Student Symposium as shown through their school's:
 - On-time attendance and active participation by a member of the ASCE Student Chapter at the Student Symposium Business Meeting
 - Participation in the Student Symposium Paper Competition, including submission and presentation by a member of the ASCE Student Chapter. Note that any papers/presentations created for any other competition do not count as an entry into the Student Symposium Paper Competition.

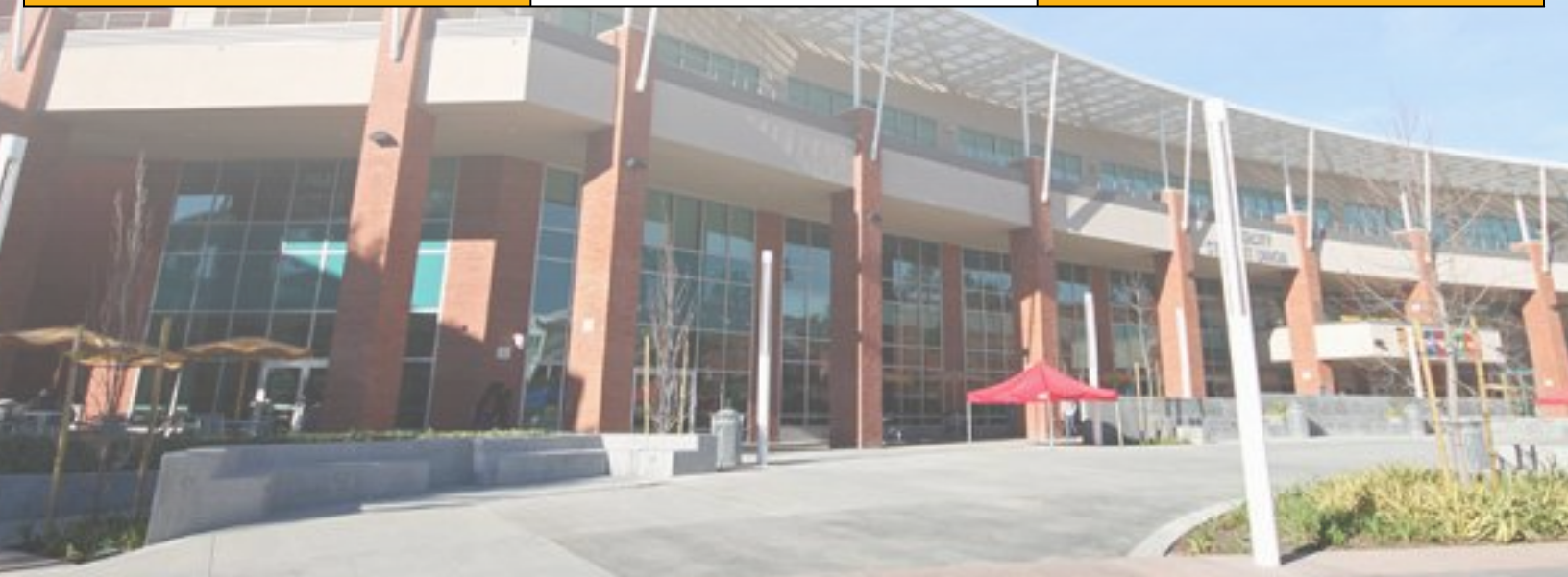
